We would like to publicize your Letter of Kosher Certification and share your product information. Please review the details below and check off all the options for those which you would like to participate:

- ☐ We can **list your Letter of Certification (LOC) on our website**, so other kashrus agencies, manufacturers and consumers may verify your kosher product list and status. Listing your Letter of Certification on the internet will help eliminate the need to send copies to your customers. After giving the cRc permission to publish we will send you a website-ready cRc logo and link information to add to your website to drive your clients to your updated LOC.
- ☐ The cRc also offers the opportunity for you to have **your company's website link** added to the cRc LOC page. The cRc website visitor would then be able to view your website at a click of the mouse.
- ☐ We would like to include your LOC information in our **Universal Kosher Database** that would give other supervising kosher agencies your LOC information in a database format. This format makes it easy for all the UKD participating kosher agencies to bring up your product(s) name, code, group, status, etc. Only information that appears on your LOC is included in this data! If you would like your information shared, please select at which security level you would like your information published. Note: generally, if you are allowing us to publish your LOC on our website, select Security Level 1.
 - ☐ Security Level 1 – includes all information that is stated on your LOC and is available to the public via the other UKD kosher supervising agencies' websites.
 - ☐ Security Level 2 – includes all information that is stated on your LOC but is only available to clients of the other kosher companies participating in the UKD via the other UKD kosher supervising agencies' websites.
 - ☐ Security Level 3 – includes all information that is stated on your LOC but is only available to the employees of other kosher supervising companies participating in the UKD. Your information would not be published on their websites.
 - ☐ Security Level 4 – excludes your company name, product names, and product codes. Anyone looking up products of this level has a hardcopy of the LOC already and is just confirming the expiration date, group number, and DPM (dairy, pareve, or meat status). This level of security is used for those companies not wanting their full list of products available to anyone.
- ☐ Finally, if you provide us with a **JPG copy of your logo** we may use it in our client database (EZcRc.org), in-house displays, our food show booth displays, or our website.

All of these services are offered to you at no additional cost or obligation. We only ask that you check off the above boxes for which you would like to participate and then sign this letter and either fax it back to 773-465-6929 Attention: cRc Contracts or email it to cRcContracts@cRcweb.org. Company JPG logos should be emailed.
