## GALIL VEGETABLES

**Issue:** Certain Galil products that are certified kosher by the Orthodox Union bear an unauthorized "Kosher for Passover" statement and may be kitnios.

## SOY PRODUCTS

The cRc does not certify any products as kosher for Pesach if they contain *kitnios*, and therefore since soy is *kitnios* we cannot certify any soy milks for *Pesach*. Nevertheless, there are individuals whose doctors order them to consume soy milk, and under many circumstances the halacha allows for such people to consume *kitnios* (after receiving permission from their Rabbi) assuming the product does not contain any true *chametz*.

In recognition of this need, the cRc is able to recommend **Vitasoy Ethnic Original Soy Milk** for such individuals. [Please note that other Vitasoy products contain barley (*chametz*) and therefore this recommendation is limited to the Ethnic variety].
