### Coffee

ALL instant coffee must bear Passover certification.

Decaffeinated coffee requires Passover certification.

Folgers and Tasters Choice Instant Coffee – unflavored, regular, **not decaffeinated**- are acceptable without special certification for Passover.

The following coffees are kosher for Passover only when bearing the kosher symbol and the letter P:

Maxim

Maxwell House

Sanka

Yuban

Whole Bean and Fresh Ground Bean:

Unflavored plain (not decaffeinated) ground or whole bean coffees do not need special certification for Passover.
